1.3 billion tonnes/year of non-agriculture waste in EU of which 60 million are hazardous waste.

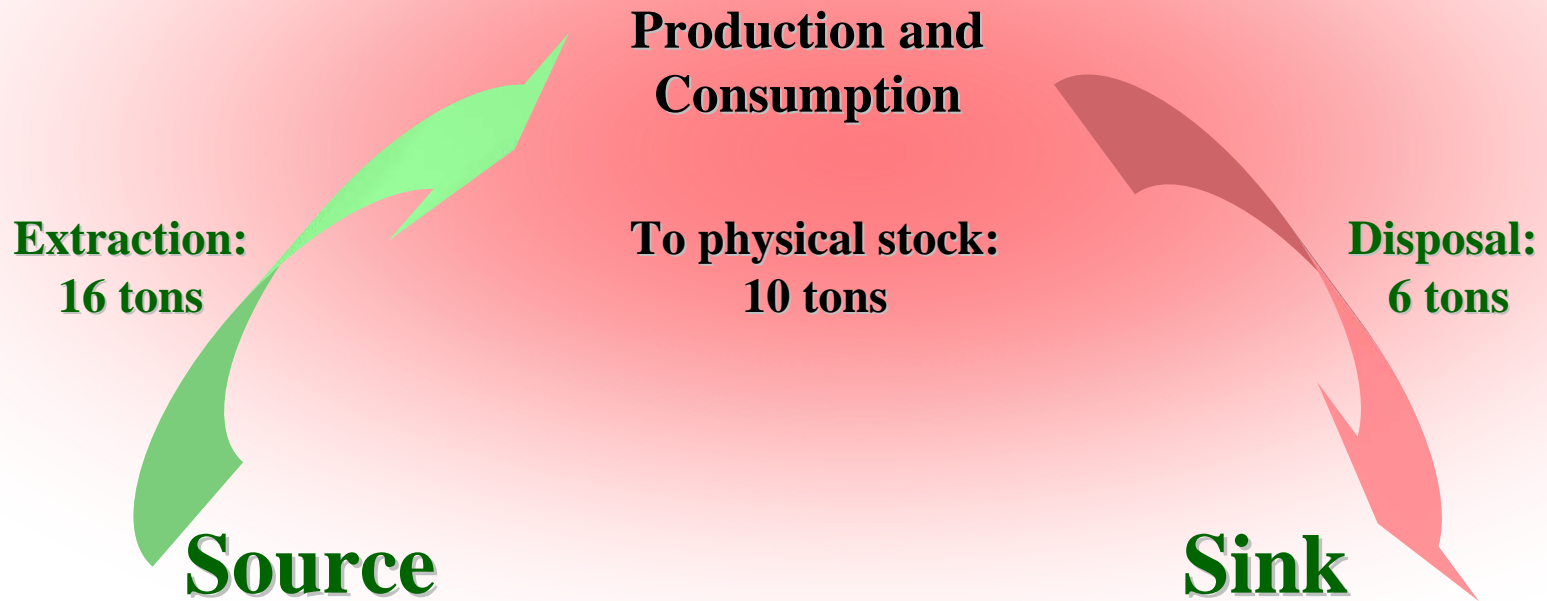
EU-15: 570 Kg per capita per annum

Implementation of EU Landfill Legislation

Waste acceptance criteria

- **Council Decision 2003/33/EC applicable since 16 July 2005**
- **No transparency as to how waste acceptance criteria are applied in different MS.**
- **The Commission is currently analysing the implementation rate in MS**
- **An ongoing IMPEL project is working on improving the understanding and knowledge of the Landfill Directive and Waste Acceptance Decision**

↓ = Waste policy objectives

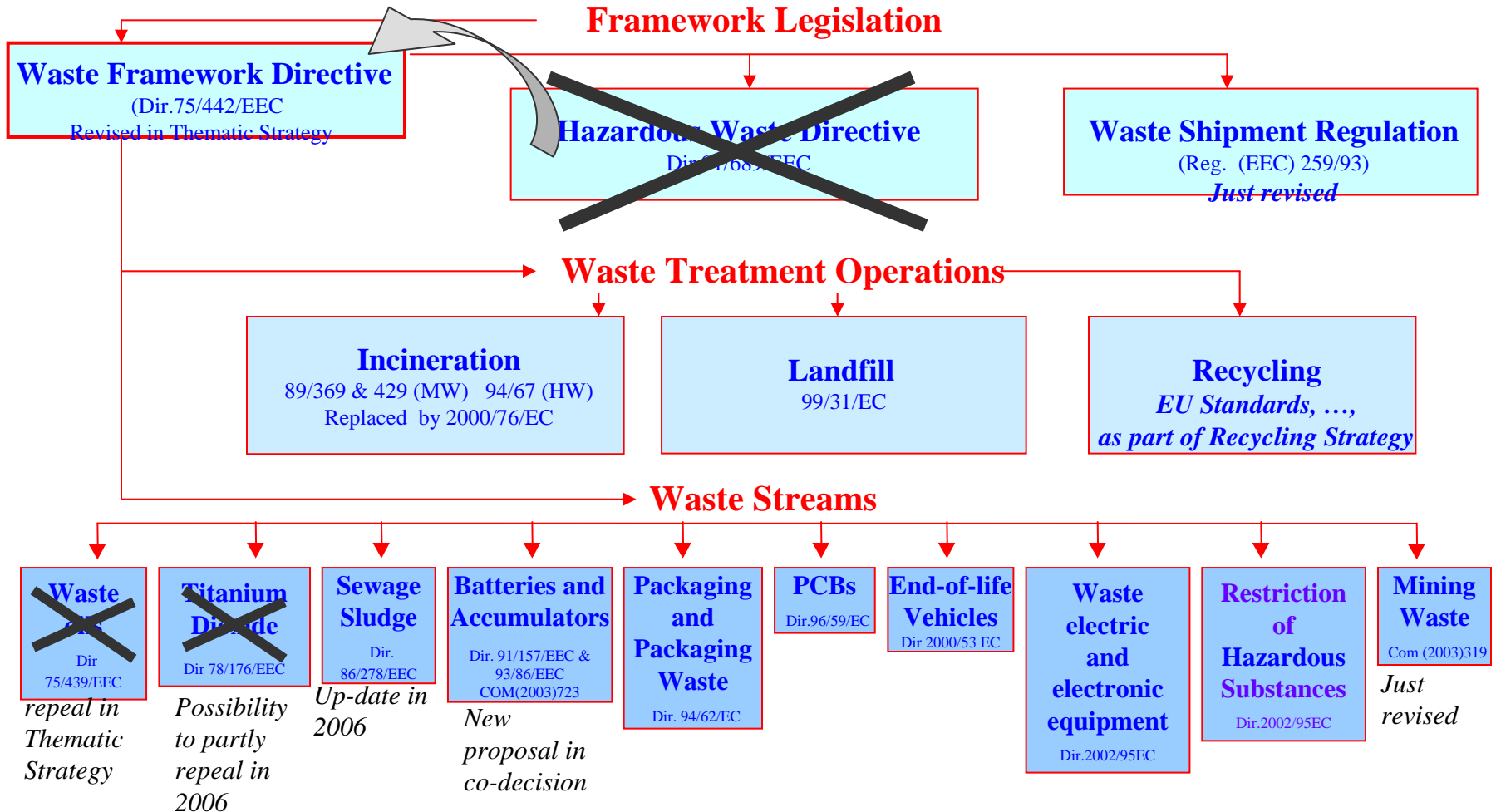

Implementation, implementation & implementation

- Thousands of illegal landfills
- More than 1 on 4 shipments of waste found to be illegal
- Heightening number of infringement cases
- Bottomline: still high risk of damage to health and safety



Implementation of EU Landfill Legislation Enforcement

■ Infringement proceedings Art. 226 EC

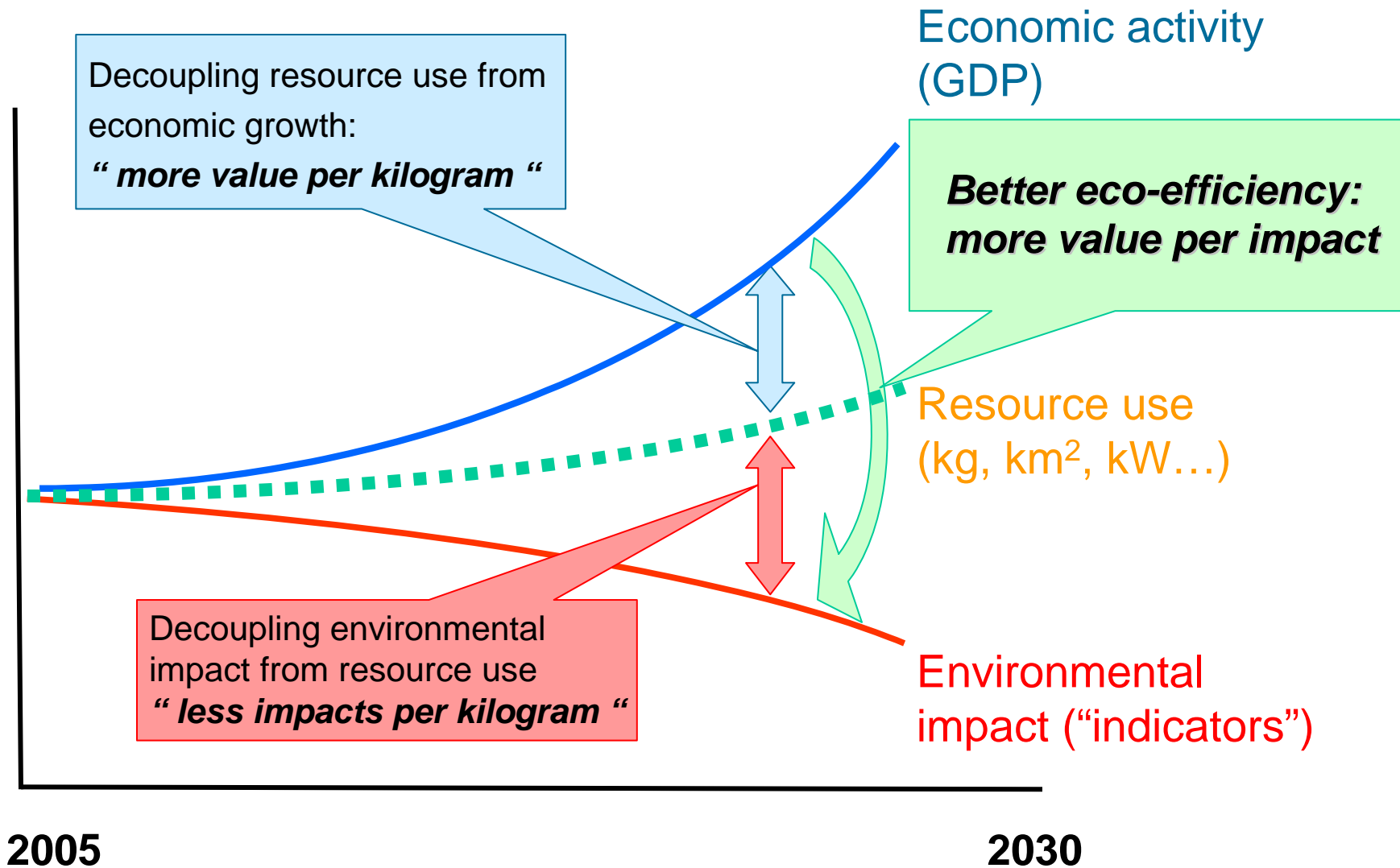
- Letter of formal notice
- Reasoned opinion

■ Infringement proceedings Art. 228 EC

- Lump sum or penalty depend on:
 - Seriousness of infringement (factor x)
 - Duration (factor x)
 - Deterrent effect (factor x)

■ Daily penalties of 140.000€ or a lump sum of 20.Mio € are not uncommon
